## ESTATE AGENTS ORDINANCE (Chapter 511)

Pursuant to section 30 of the Estate Agents Ordinance, it is hereby notified that the Disciplinary Committee of Estate Agents Authority has exercised the following disciplinary power against the following licensee:—

The licensee:-

- (i) amended a term in the provisional tenancy agreement ('PTA') that
  the transacting party had already signed without obtaining the
  party's prior written consent or arranged for her to initial against
  the amendment as confirmation;
- (ii) in handling a tenancy transaction of a residential property ('the Property'), handed over the initial deposit paid by the tenant to the landlord while the tenant and the landlord had yet to have consensus on the break clause of the PTA of the Property; and
- (iii) misrepresented to the landlord that the tenant had given consent to the amendments to the break clause of the PTA of the Property.

  - In respect of the aforesaid matter (i):—
    (a) The licensee is reprimanded; and
  - (b) A condition is attached to the licensee's licence requiring the licensee to attend and complete activities under the Estate Agents Authority Continuing Professional Development Scheme 'Compliance and Effective Management' category by way of seminars or lectures only and thereby acquire 12 points recognised by the Estate Agents Authority within 12 months.
- 2. In respect of the aforesaid matter (ii):—
  - (a) The licensee is reprimanded;
  - (b) The licensee is fined HK\$1,000; and
  - (c) A condition is attached to the licensee's licence requiring the licensee to attend and complete activities under the Estate Agents Authority Continuing Professional Development Scheme 'Compliance and Effective Management' category by way of seminars or lectures only and thereby acquire 12 points recognised by the Estate Agents Authority within 12 months
- 3. In respect of the aforesaid matter (iii):—
  - (a) The licensee is reprimanded;
  - (b) The licensee is fined HK\$2.000; and
  - (c) A condition is attached to the licensee's licence requiring the licensee to attend and complete activities under the Estate Agents Authority Continuing Professional Development Scheme 'Compliance and Effective Management' category by way of seminars or lectures only and thereby acquire 12 points recognised by the Estate Agents Authority within 12 months, and at least 3 points of which shall be acquired from seminars or lectures on the Professional Ethics and Integrity subject.

With regard to paragraphs 1(b), 2(c) and 2(c) above, the Disciplinary Committee, having regard to the principle of totality, decided that the following condition is attached to the licence concerned of the licensee:—

'The above-named licensee shall, during the period of 24 months from 22 April 2024 to 21 April 2026, attend and complete activities under the Estate Agents Authority Continuing Professional Development Scheme 'Compliance and Effective Management' category by way of seminars or lectures only and thereby acquire 24 points recognised by the Estate Agents Authority, and at least 3 points of which shall be acquired from seminars or lectures on the Professional Ethics and Integrity subject.'
