Explanatory Note

This Regulation amends the Road Traffic (Public Service Vehicles) Regulations (Cap. 374 sub. leg. D) (*principal Regulations*) to adjust certain fares specified in Schedule 5 to the principal Regulations. Under the adjustment—

- (a) for taxis licensed to operate in Hong Kong and Kowloon—
 - (i) the fare for the first 2 kilometres is increased from \$27.00 to \$29.00; and
 - (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.90 to \$2.10 until reaching \$102.50 (the current corresponding amount of which is \$93.50), and from \$1.30 to \$1.40 after reaching \$102.50;
- (b) for taxis licensed to operate within Lantau—
 - (i) the fare for the first 2 kilometres is increased from \$22.00 to \$24.00; and
 - (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.70 to \$1.90 until reaching \$195.00 (the current corresponding amount of which is \$175.00), and from \$1.50 to \$1.60 after reaching \$195.00; and
- (c) for taxis licensed to operate in the New Territories—
 - (i) the fare for the first 2 kilometres is increased from \$23.50 to \$25.50; and
 - (ii) the fare for every further 200 metres and the fare for waiting time for every 1 minute are each increased from \$1.70 to \$1.90 until reaching
