  - "(6G) During the period from 1 October 2022 to 30 September 2023 (both dates inclusive), the table to paragraph (1) has effect as if the fees specified in items 1, 2, 3, 4, 5 and 6 of the table were zero.
    - (6H) Paragraph (6G) and this paragraph expire at midnight on 30 September 2023."."

# **Explanatory Note**

This Regulation amends the Dangerous Goods (Control) Regulation (Cap. 295 sub. leg. G) (*principal Regulation*) to provide for concessions on certain fees payable during the period from 1 October 2022 to 30 September 2023 in relation to licences and permits for Schedule 1 dangerous goods as defined by the Dangerous Goods (Application and Exemption) Regulation 2012 (Cap. 295 sub. leg. E).

2. This Regulation also amends the principal Regulation to supplement the transitional provisions relating to the repeal of the Dangerous Goods (General) Regulations (Cap. 295 sub. leg. B) (*Cap.* 295B) so that the concessions on certain fees payable in relation to licences and permits for dangerous goods in category 1 under Cap. 295B are extended for another year (1 October 2022 to 30 September 2023).
