## PROPOSED ROAD WORKS AT WAN ON STREET, WAN LOK STREET, WAN HING STREET, WAN FAT STREET, WAN TAT STREET, WING KWONG STREET, BAILEY STREET, KAI MING STREET, HUNG FOOK STREET AND NGAN HON STREET, TO KWA WAN, KOWLOON

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway, footpaths and pedestrian crossings on Wing Kwong Street, a section of existing footpath between Hung Fook Street and Kai Ming Street; sections of existing footpaths between Kai Ming Street and Wing Kwong Street within the limit of works area as shown on Plan No. KM10291 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2423 published on 15 May 2020 and 22 May 2020. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that as from 7 June 2022, all public or private rights in, upon, under or over the sections of the existing carriageway, footpaths and pedestrian crossings on Wing Kwong Street, a section of existing footpath between Hung Fook Street and Kai Ming Street; sections of existing footpaths between Kai Ming Street and Wing Kwong Street to be permanently closed, shall be extinguished.

The works to be carried out in association with this closure mainly involve the construction of carriageways and lay-bys, the conversion of sections of the existing footpaths into carriageways and lay-bys, the conversion of a section of the existing carriageway into footpath, the conversion of the existing pedestrian crossings into carriageway, and other ancillary works.

A copy of the order and the Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageway, footpaths and pedestrian crossings on 27 May 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
