Adequate precautionary measures to ensure public safety should be provided prior to and during the course of works:
  4. You are required to commence the works ordered by me in paragraph 3 above within 30 days and complete such works within 60 days of the date of this order, all to the satisfaction of the Building Authority.

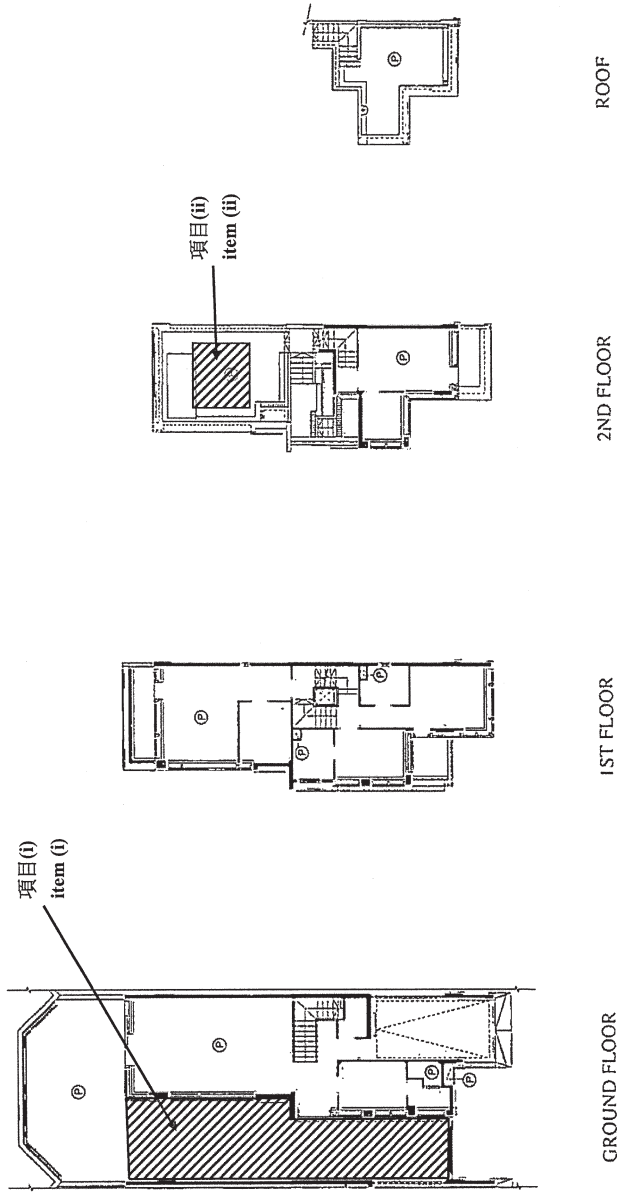
