- 3. The liabilities do not include the Green Bonds (equivalent to HK\$192,529 million as at 31 March 2024) issued under the Government Green Bond Programme. They were denominated in US dollars (US\$9,950 million with maturity from May 2024 to January 2053), euros (4,580 million euros with maturity from January 2025 to November 2041), Renminbi (RMB31,500 million with maturity from November 2024 to June 2033) and HK dollars (HK\$42,000 million with maturity from May 2025 to October 2026) respectively for the purposes of the Capital Works Reserve Fund under section 3(1) of the Loans Ordinance (Cap. 61). During the financial year up to 31 March 2024, there were payments of interest of HK\$3,767 million and repayment of principal with nominal value of HK\$800 million on the Green Bonds.

4. The consolidated fund balance includes HK\$364,957 million being the balance of the Land Fund held in the name of Future Fund, for long term investments up to 31 December 2030. The Future Fund also includes HK\$4,800 million, being one-third of the actual surplus in 2015-16 as top up. In June 2020, in a bid to uphold Hong Kong's status as an international aviation hub, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to allocate HK\$27.3 billion of the Land Fund (via the Future Fund) to invest in Cathay Pacific Airways Limited. On 12 August 2020, HK\$19.5 billion was drawn from the assets of the Land Fund placed with the Exchange Fund for the investment in Cathay Pacific Airways Limited, comprising preference shares with detachable warrants. The investment would remain as a part of the Future Fund. The investment is held by Aviation 2020 Limited, a dedicated company wholly-owned by the Financial Secretary Incorporated as established under the Financial Secretary Incorporation Ordinance (Cap. 1015). On 4 December 2023, Cathay Pacific Airways Limited redeemed 50% of the preference shares that were held by Aviation 2020 Limited (i.e. principal amount of HK\$9.75 billion).

The Financial Secretary announced in the 2020-21 Budget Speech that part of the Future Fund would be used to establish the Hong Kong Growth Portfolio (HKGP) to make strategic investments in projects with a Hong Kong nexus. The objectives of HKGP are to reinforce Hong Kong's status as a financial, commercial and innovation centre, as well as raising Hong Kong's productivity and competitiveness in the long run, while seeking reasonable risk-adjusted returns. The Chief Executive announced in the 2022 Policy Address that the Hong Kong Investment Corporation Limited will consolidate the management of the investment activities of the HKGP and the Co-Investment Fund.

In October 2023, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to draw HK\$1,263 million from the assets of the Land Fund for investment in Cyberport in the form of an interest-bearing term loan facility to finance Cyberport's development of the Artificial Intelligence Supercomputing Centre in Hong Kong.

In June 2020, in a bid to uphold Hong Kong's status as an international aviation hub, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to allocate HK\$27.3 billion of the Land Fund (via the Future Fund) to invest in Cathay Pacific Airways Limited. On 12 August 2020, HK\$19.5 billion was drawn from the assets of the Land Fund placed with the Exchange Fund for the investment in Cathay Pacific Airways Limited, comprising preference shares with detachable warrants. The investment would remain as a part of the Future Fund. The investment is held by Aviation 2020 Limited, a dedicated company wholly-owned by the Financial Secretary Incorporated as established under the Financial Secretary Incorporation Ordinance (Cap. 1015). On 4 December 2023, Cathay Pacific Airways Limited redeemed 50% of the preference shares that were held by Aviation 2020 Limited (i.e. principal amount of HK\$9.75 billion).

The Financial Secretary announced in the 2020-21 Budget Speech that part of the Future Fund would be used to establish the Hong Kong Growth Portfolio (HKGP) to make strategic investments in projects with a Hong Kong nexus. The objectives of HKGP are to reinforce Hong Kong's status as a financial, commercial and innovation centre, as well as raising Hong Kong's productivity and competitiveness in the long run, while seeking reasonable risk-adjusted returns. The Chief Executive announced in the 2022 Policy Address that the Hong Kong Investment Corporation Limited will consolidate the management of the investment activities of the HKGP and the Co-Investment Fund.

In October 2023, the Financial Secretary exercised his authority under a resolution made under the Public Finance Ordinance (Cap. 2) to draw HK\$1,263 million from the assets of the Land Fund for investment in Cyberport in the form of an interest-bearing term loan facility to finance Cyberport's development of the Artificial Intelligence Supercomputing Centre in Hong Kong.
