- (i) be deposited personally in the Hong Kong Housing Authority Tender Box situated at Regional Management Office/Hong Kong Island and Islands (Sub Office), Unit 207–214, Po Ning House, Po Lam Estate, Tseung Kwan O, New Territories, Hong Kong, or

Late tenders or tenders not submitted in accordance with the requirements stipulated as above will not be considered.

The tender closing time and date will automatically be deferred to 10.00 a.m. on the first working day (excluding Saturday) in the following circumstances:—

- (a) if tropical cyclone warning signal No. 8 or above is hoisted and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (b) if a black rainstorm warning signal or ‘extreme conditions’ is announced by the Government and remains in force for any duration within two (2) hours before the tender closing time on the tender closing date; or
- (c) when the Director of Housing announces the closure of the Regional Management Office/Hong Kong Island and Islands (Sub Office) at the Unit 207–214, Po Ning House, Po Lam Estate, Tseung Kwan O, New Territories, Hong Kong due to unforeseen circumstances and the office remains closed for any duration within two (2) hours before the tender closing time on the tender closing date.

For the avoidance of doubt, the tender closing time will remain unchanged if black rainstorm warning signal or tropical cyclone signal No. 8 or above or ‘extreme conditions’ is lowered or cancelled or the Regional Management Office/Hong Kong Island and Islands (Sub Office) is reopened, two (2) hours or more before the tender closing time on the tender closing date.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The Hong Kong Housing Authority does not bind itself to accept the highest combined score tender or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
