Location : Junction of Sai Ning Street and Victoria Road, Kennedy Town, Hong Kong  
Area : 2 260 square metres (about)  
Building Covenant: On or before 30 September 2032  
Annual Rental : An amount equal to 3% of the rateable value from time to time of the lot  
Lease Term : A term of 50 years commencing from the date of the Memorandum of Agreement  
User : Non-industrial (excluding godown, hotel and petrol filling station) purposes  
Total Gross Floor Area : (i) 22 600 square metres and not less than 13 560 square metres for private residential purposes; and  
(ii) The maximum gross floor area for non-industrial (excluding private residential, godown, hotel and petrol filling station) purposes is computed according to the relevant special condition in the Conditions of Sale.

In case a Black Rainstorm Warning Signal or a Tropical Cyclone Warning Signal No. 8 or above or an announcement on ‘extreme conditions’ caused by super typhoon is issued by the Government at any time between 9.00 a.m. and 12.00 noon on the said date, the tender closing time will be extended to 12.00 noon on the first working day of the following week and on which no Black Rainstorm Warning Signal or Tropical Cyclone Warning Signal No. 8 or above or announcement on ‘extreme conditions’ caused by super typhoon is issued by the Government at any time between the hours of 9.00 a.m. and 12.00 noon. In case the public access to the Government Secretariat Tender Box is blocked or for any reason becomes inaccessible at any time between 9.00 a.m. and 12.00 noon on the said date, the Government will announce the extension of the tender closing time until further notice. Where an announcement has been made for the extension of the tender closing time until further notice, upon the removal of the blockage or inaccessibility, the Government will as soon as practicable announce the revised tender closing time. The above announcements will be made *via* press releases on the website of the Information Services Department ([www.info.gov.hk/gia/general/today.htm](http://www.info.gov.hk/gia/general/today.htm)). Late tenders and tenders not deposited in the Government Secretariat Tender Box in accordance with the aforesaid provisions will not be accepted.
