

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 3/WSD/23: Improvement Works to Fresh Water Mains with Internal Bitumen Lining—First Package of High Priority Mains in New Territories East and New Territories West—Stage One**. The works are for implementing the stage one improvement works to the first package of high priority mains with internal bitumen lining. The proposed scope of the project comprises (a) replacement and rehabilitation of fresh water mains with internal bitumen lining in the Sai Kung District and Tuen Mun District; and (b) associated works including abandonment of replaced water mains and installation of strainers. The works are scheduled to commence in December 2023 and will take about 62 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 28 July 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 28 July 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in effect. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 28 July 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Contractors on the List of Approved Contractors for Public Works in Group C under the Waterworks Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Waterworks Category, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (a) The tenderer has completed at least one (1) waterworks contract with adjusted contract sum of not less than HK\$500 million within the past ten (10) years in or outside Hong Kong.
- (b) The mandatory pre-bid subcontractor:—

- (i) Design works under Early Contractor Involvement (ECI) Stage 1 and the other design work as indicated in the contract

The minimum requirements for Subcontractor's/tenderers' experience and technical capability for the works stipulated in (i) above:—

- a. the proposed Subcontractor shall be on the List of Consultants of Engineering & Associated Consultants Selection Board (EACSB) under the category of Waterworks (WS).

- (ii) Traffic consultant to facilitate the construction works in the contract

The minimum requirements for Subcontractor's/tenderers' experience and technical capability for the works stipulated in (ii) above:—

- a. the proposed Subcontractor shall be on the List of Consultants of Engineering & Associated Consultants Selection Board (EACSB) under the category of Traffic and Transport (TT).

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C for the Waterworks Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 23 June 2023 to Chief Engineer/Consultants Management, Consultants Management Division, New Works Branch, Water Supplies Department at 6th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
