TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings within the limit of works area as shown on Plan No. CDEKAT0002 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 5963 published on 27 September 2019 and 4 October 2019. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 12 June 2022 to 11 June 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the modification of carriageways, footpaths, central medians/traffic islands and pedestrian crossings at the junction of Hoi Bun Road and Cheung Yip Street, as well as other ancillary works.
