

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 7471RO
 THE ESTABLISHMENT OF AN AGRICULTURAL PARK IN
 KWU TUNG SOUTH—PHASE 2 FIRST STAGE—ROAD WORKS

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plan No. 3540/P2/GZ/211 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a carriageway, footpaths, verges, refuge islands, pedestrian crossings and a run-in/run-out;
- (ii) permanent closure and conversion of sections of the existing carriageway into footpaths;
- (iii) permanent closure and conversion of sections of the existing footpaths into a carriageway;
- (iv) permanent closure and conversion of sections of the existing verges into a carriageway and footpaths;
- (v) permanent closure and demolition of sections of the existing footpaths;
- (vi) permanent closure and conversion of a section of the future footpath under PWP Item No. 7471RO The Establishment of an Agricultural Park in Kwu Tung South (Phase 1)—Road Works ('Agricultural Park Phase 1 Project') into a carriageway;
- (vii) permanent closure and conversion of a section of the future verge under Agricultural Park Phase 1 Project into a footpath;
- (viii) temporary closure and reconstruction of sections of the existing carriageway, footpaths and run-ins/run-outs;
- (ix) temporary closure and reconstruction of sections of the future carriageway and footpath under Agricultural Park Phase 1 Project; and
- (x) ancillary works including geotechnical, drainage, sewerage, water supplies, utilities, lighting, landscaping, electrical and mechanical works, installation of street furniture, traffic aids, traffic control and surveillance system, as well as construction of retaining walls.

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Logistics an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Any objection lodged on a ground relating to any compensation (whether monetary or non-monetary) or any financial or other assistance in connection with the works or the use is, to the extent that it is lodged on that ground, invalid and treated as not having been lodged for the purposes of section 11 of the Ordinance. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 23rd day of July 2024.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to further process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
