

It is hereby notified that sealed tenders in triplicate are invited for **Tender No. RTHK 1/PT/8/2024, Provision of Electrical and Mechanical Maintenance Services for Radio Television Hong Kong**. The works include the engineering services of electrical and mechanical installations and other services at Broadcasting House and Television House. The works are scheduled to commence in April 2025 and will take about 36 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box in Room 503, 5/F, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 5 July 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 5 July 2024, the tender closing time will be extended to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 or above is lowered, or the black rainstorm warning signal or the 'extreme conditions' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 5 July 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
