- You are required to commence the works ordered by me in paragraph 1 above within <u>30</u> days and complete such works within <u>60</u> days of the date of this order, all to the satisfaction of the Building Authority.
- 3. For the said building works in paragraph 1 above:
 - (a) Items (i) to (ii) have been carried out without having first obtained from me the approval of building plans and consent for the commencement of such building works required by section 14 of the Buildings Ordinance.
 - (b) The building works at item (ii) above, Regulation 41(1) of the Building (Planning) Regulations, which requires the building to be provided with such means of escape in case of emergency as required by the intended use of the building, has been contravened.
