Instead, a purple Check List will be published in the next issue of replacement pages to direct users to HKeL. Further, new principal subsidiary legislation published in the Gazette after 2 June 2016 will not be published in the Loose-leaf Edition but will be made available in HKeL. Such new principal subsidiary legislation and subsidiary legislation replaced by purple Check Lists are not covered by this index.
- 5. Users may refer to HKeL to see whether a verified copy of a piece of subsidiary legislation is available in HKeL.
