

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. CV/2022/09, Reconstruction of Yung Shue Wan Public Pier and Shek Tsai Wan Pier (Public Works Programme Item Nos. 5055TF and 5056TF)**. The works mainly comprise demolition of the existing Yung Shue Wan Public Pier and Shek Tsai Wan Pier, construction of two new piers at Yung Shue Wan and Shek Tsai Wan and associated piling works, and provision of floating platforms at the two new piers.

The works are scheduled to commence in the 4th quarter of 2022 and will take about 36 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board, and placed in the Public Works Tender Box situated at the Room 503 on the 5th Floor, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong, before 12.00 noon on Friday, 5 August 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 5 August 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 5 August 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
