The scope of the works includes provide the maintenance service and modification works of existing Traffic Control and Surveillance System at Open Road Section of Hong Kong Link Road and Tuen Mun Chek Lap Kok Link Southern Connection. The contract is scheduled to commence in September 2024 for expiry in September 2027.

Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon, on Friday, 19 July 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
