ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

PWP ITEM NO. 6191TB (PART)  
PROPOSED PEDESTRIAN ENVIRONMENT IMPROVEMENT WORKS  
IN KWUN TONG BUSINESS AREA—NGAU TAU KOK PORTION

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. GAZ/001 to GAZ/004 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a subway, lifts, a pedestrian crossing, an underground adit and staircases;
- (ii) permanent closure and conversion of sections of the existing carriageway into footpaths, a subway staircase entrance and a lift;
- (iii) permanent closure and conversion of sections of the existing footpaths into a carriageway, amenity areas, an open space and a lift;
- (iv) permanent closure and conversion of a section of the existing subway into a lift;
- (v) permanent closure and conversion of sections of the existing amenity area into a footpath and a lift;
- (vi) permanent closure and conversion of sections of the existing open spaces into footpaths, an amenity area, a subway staircase entrance, a staircase and a lift;
- (vii) permanent closure and conversion of sections of the existing ramp into a footpath and a staircase;
- (viii) permanent closure and conversion of sections of the existing subway staircase entrances into footpaths and an amenity area;
- (ix) permanent closure and conversion of a section of the existing subway ramp entrance into an open space;
- (x) permanent closure and conversion of sections of the existing central reserves/traffic islands into carriageways, a footpath and a lift;
- (xi) demolition and conversion of a section of the existing subway ramp entrance cover into a footpath;
- (xii) permanent closure of sections of the existing subways and pedestrian crossings;
- (xiii) temporary closure and reconstruction of sections of the existing footpaths, subways, open space, ramp and subway staircase entrances; and
- (xiv) ancillary works including drainage, water, utilities, landscaping, public lighting and electrical and mechanical works, as well as installation of street furniture and traffic aids, etc.

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Logistics an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 8th day of August 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
