

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. HY/2022/18—Improvement Works at Tsuen Tsing Interchange (Public Works Programme Item No. 6087TI)**. The works mainly include:—

- (a) construction of a traffic lane to allow exclusive left-turning traffic movement from the approach road of Tsuen Wan Road (Tuen Mun bound) to Tsing Tsuen Road (Tsing Yi bound);
- (b) construction of a single-lane vehicular bridge and associated slip road at Texaco Road (westbound) to connect to an existing vehicular bridge section towards Tsing Yi not yet opened to traffic above Tsuen Tsing Interchange;
- (c) construction of a single-lane slip road connecting down ramp of Tsuen Wan Road (Kowloon bound) to Texaco Road (Ma Tau Pa Road bound);
- (d) widening of a section of Texaco Road (eastbound) to the north of Tsuen Tsing Interchange;
- (e) widening the roundabout at Tsuen Tsing Interchange and improving its junctions; and
- (f) associated works including geotechnical, drainage, installation of traffic aids, public lighting and landscaping works.

The works are scheduled to commence in the fourth quarter of 2023 and will take about 30 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 4 August 2023 (tender closing date). Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer has completed at least one construction contract involving roads and drainage works with an adjusted contract sum of not less than HK\$400 million, in or outside Hong Kong, within the past five years counting from but excluding the original date set for the close of tender. The adjusted contract sum shall be the awarded contract sum being adjusted to current price level as stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 5 July 2023 to Chief Engineer 5/Major Works, Major Works Project

Management Office, Highways Department, at 3rd Floor, Ho Man Tin Government Offices, 88 Chung Hau Street, Ho Man Tin, Kowloon, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
