

**RAILWAYS ORDINANCE (Chapter 519)****(Notice under Section 6(4))****TUNG CHUNG LINE EXTENSION****Amendments to Scheme under section 7**

TAKE NOTICE that pursuant to section 7 of the Railways Ordinance (Chapter 519), the Secretary for Transport and Housing proposes to amend the scheme for the Tung Chung Line Extension, which was referred to in G.N. 7687 published on 10 and 17 December 2021.

TAKE FURTHER NOTICE that the Secretary for Transport and Housing proposes the amendments to the scheme, as described in the Amendments to Scheme and shown on 'Revision 1' of the General Layout Plan No. TCLE-G01; 'Revision 1' of the Land Resumption Plan No. TCLE-L01; 'Revision 1' of the Creation of Rights of Temporary Occupation of Land Plan No. TCLE-T01; and 'Revision 1' of the Control of Building Plans and Commencement of Work Plan No. TCLE-P01 (the 'Amendment Plans') annexed thereto. The Amendments to Scheme and the Amendment Plans have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:-

Any person who wishes to object to the Amendments to Scheme or any part of them is required to address his objection in writing to the Secretary for Transport and Housing so as to reach the Secretary for Transport and Housing not later than 23 August 2022, describing his interest and the manner in which he alleges he will be affected by the amendments to the scheme. Objections can be submitted via one of the following means:

Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
