

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 1202EM24T, Quadrennial Term Contract for Maintenance and Repair of Electrical and Floodlight Installations for Hong Kong Police Force, Correctional Services Department, Fire Services Department, Hong Kong Independent Commission Against Corruption, Security Bureau and Drainage Services Department in New Territories and Hong Kong Island.** The scope of the works includes the Preventive Maintenance Service, Corrective Maintenance Service, Alternations, Additions and Improvement Works for the Electrical and Floodlight Installations for Hong Kong Police Force, Correctional Services Department, Fire Services Department, Hong Kong Independent Commission Against Corruption, Security Bureau and Drainage Services Department in New Territories and Hong Kong Island. The contract is scheduled to commence in November 2024 for expiry in October 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Public Works Tender Board and placed in the Public Works Tender Box situated in Room 503, 5/F, Low Block, Queensway Government Offices, 66 Queensway, Hong Kong before 12.00 noon on Friday, 26 July 2024. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 26 July 2024, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 26 July 2024, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
