

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. 2/WSD/23: Improvement of Fresh Water Supply Systems in Sham Shui Po, Eastern, Central and Western Districts**. The works comprise improvement of fresh water supply systems in Sham Shui Po, Eastern, Central and Western districts. The proposed scope of the project comprises (a) replacement and rehabilitation of high priority fresh water mains with bitumen lining in Sham Shui Po and Eastern districts; (b) laying of fresh water mains in Central and Western districts; and (c) other associated works. The works are scheduled to commence in December 2023 and will take about 55 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 11 August 2023. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 11 August 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in effect. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 11 August 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Waterworks Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Waterworks Category, who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

(a) The tenderer has completed at least one (1) construction contract involving waterworks with an adjusted contract sum at the time of contract award of not less than HK\$380 million in or outside Hong Kong within the past ten (10) years counting from the original date set for the close of tender.

(b) The mandatory pre-bid subcontractor:—

(i) *Design works under Early Contractor Involvement (ECI) in section II and III of works*

The minimum requirements for Subcontractor's/tenderers' experience and technical capability for the works stipulated in (i) above:—

a. the proposed Subcontractor shall be on the List of Consultants of Engineering and Associated Consultants Selection Board (EACSB) under the category of Waterworks (WS).

(ii) *Traffic consultant to facilitate the design of section II and III of works*

The minimum requirements for Subcontractor's/tenderers' experience and technical capability for the works stipulated in (ii) above:—

a. the proposed Subcontractor shall be on the List of Consultants of Engineering and Associated Consultants Selection Board (EACSB) under the category of Traffic and Transport (TT).

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C for the Waterworks Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 14 July 2023 to Chief Engineer/Consultants Management, Consultants Management Division, New Works Branch, Water Supplies Department at 6th Floor, Sha Tin Government Offices, 1 Sheung Wo Che Road, Sha Tin, New Territories, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date. A charge will be levied for delivery of tender documents where the delivery of tender documents is requested by a tenderer. A written request must be made.
