

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and cycle tracks within the limit of works area as shown on Plans Nos. 60044963/GAZ/1001 to 60044963/GAZ/1003 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 5157 published on 21 August 2009 and 28 August 2009. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 21 July 2022 to 20 July 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and cycle tracks to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the modification and rectification works on a plaza and along Lung Fu Road and Lung Mun Road at Tuen Mun, and associated works.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Housing a written claim, which can be submitted *via* one of the following means,

before the expiration of one year from the date of closure, extinction, modification or restriction:—
