

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. IS/2022/01, Improvement Works at Tai O—Phase 2, Stage 2 (Public Works Programme Item No. 417RO-1B)**. The works include:—

- (a) construction of a footbridge at Yim Tin with a clear width of about 3 metres (m) and total length of about 140 m;
- (b) construction of a footbridge at Po Chue Tam with a clear width of about 3 m and total length of about 120 m;
- (c) construction of an amphitheatre-cum-open space and a public car park at Yim Tin;
- (d) upgrading works of the open area in front of Yeung Hau Temple; and
- (e) implementation of environmental mitigation measures for the works mentioned in items (a) to (d) above.

The works are scheduled to commence in late 2022 and will take about 32 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Office, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 12 August 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 12 August 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 12 August 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated below are invited to tender:—

- (1) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has undertaken at least one (1) completed construction contract involving road works with an adjusted contract sum of not less than HK\$74 million in or outside Hong Kong within the past ten (10) years counting from the original date set for the close of tender or has undertaken at least one (1) ongoing construction contract involving road works with an adjusted contract sum of not less than HK\$74 million in or outside Hong Kong more than one (1) year but not exceeding ten (10) years before the original date set for the close of tender. The adjusted contract sum shall be the awarded contract sum being adjusted to current price level as stipulated in the tender documents.

The detailed requirements for joint ventures with participation of local and/or overseas contractors, if applicable, are stipulated in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group B under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned

approved list/category by 25 July 2022 to Chief Engineer/L2, Sustainable Lantau Division 2, Sustainable Lantau Office, Civil Engineering and Development Department, 13th Floor North Point Government Offices, 333 Java Road, North Point, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
