Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Tenderers may submit tender for one contract, tenders for two contracts or all of the three contracts. The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest tender (or the highest combined score for a tender adopting a marking scheme) or any tender, and reserves the right to negotiate with any tenderer about the terms of the offer.
