- (ii) (For Electronic Tendering) Transmission of the tender through the e-Tender Box shall be successfully completed in accordance with the requirements of the e-Tender Box before the tender closing time.
- (iii) Late tenders or tenders not submitted in accordance with any one of the submission methods specified in (i) or (ii) above will not be accepted.
- (iv) In case Tropical Cyclone Warning Signal No. 8 or above is hoisted, or Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force, for any duration between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be
