For electronic tendering, transmission of a tender through the ETB shall be successfully completed in accordance with the requirement of the ETB before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

In case of Tropical Cyclone Warning typhoons No. 8 or above, a Black Rainstorm Warning Signal or 'extreme condition' after super typhoons announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on 8 August 2024, the tender closing time will postponed to 12.00 noon on the first working date after the Tropical Cyclone Warning Signal No. 8 is lowered, or Black Rainstorm Warning Signal or the 'extreme conditions' after super typhoons announced by the Government has/have ceased to be in force.

In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on 8 August 2024, the Government will announce the extended tender closing time as soon as practicable. This tender is covered by the Agreement on Government Procurement of the World Trade Organization ('WTO GPA') and will not involve electronic auction. This notice also serves as a summary notice required under WTO GPA.

Open tendering is adopted. All interested contractors/suppliers/service providers are invited to tender.
