

## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

ROAD WORKS UNDER PWP ITEM NO. B837CL  
SITE FORMATION AND INFRASTRUCTURE WORKS FOR PUBLIC HOUSING  
DEVELOPMENT AT CHEUNG MAN ROAD, CHAI WAN

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 422555/CMR/GP/01 and 422555/CMR/GP/02 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of a covered footbridge, an at-grade covered pedestrian walkway, lift towers *cum* lift systems, footpaths, a carriageway, a column, pedestrian crossings and a vehicular run-in/run-out;
- (ii) permanent closure and conversion of sections of the existing carriageways into refuge islands/central medians;
- (iii) permanent closure and conversion of sections of the existing footpaths into carriageways, a refuge island/central median and a layby;
- (iv) permanent closure and conversion of a section of the existing refuge island/central median into a carriageway;
- (v) demolition and conversion of sections of the existing slopes into footpaths and a layby;
- (vi) temporary closure and reconstruction of sections of the existing carriageway and footpaths; and
- (vii) ancillary works including drainage, water, landscaping, public lighting, utilities, traffic aids, street furniture and geotechnical works, as well as construction of a retaining wall and slopes.

The Plans and scheme may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

Any person who wishes to object to the works or the use, or both, is required to address to the Secretary for Transport and Logistics an objection in writing, which can be submitted *via* one of the following means:—

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 29th day of August 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us. Request for access to or correction of the personal data should be made in writing to the Personal Data Privacy Officer of the Transport and Logistics Bureau at 20th Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong.
