## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370) (Notice under section 18)

## PROPOSED ROAD WORKS AT CHUN TIN STREET, HOK YUEN STREET AND SUNG CHI STREET. TO KWA WAN, KOWLOON

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing carriageway and footpaths (the Stippled Red Area and the Hatched Black Areas located on Chun Tin Street; and the Green Stippled Red Area located on Hok Yuen Street); and temporarily sections of the existing footpaths (the Green Hatched Black Areas located on Hok Yuen Street) within the limit of works area as shown on Plan No. KM10290 ("the Plan") and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 1363 published on 27 March 2020 and 3 April 2020. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that as from 22 July 2022, all public or private rights in, upon, under or over the sections of the existing carriageway and footpaths (the Stippled Red Area and the Hatched Black Areas located on Chun Tin Street; and the Green Stippled Red Area located on Hok Yuen Street) to be permanently closed, shall be extinguished; and from 22 July 2022 to 21 July 2023, all public or private rights in, upon, under or over the sections of the existing footpaths (the Green Hatched Black Areas located on Hok Yuen Street) to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the conversion of a section of the existing carriageway into footpath, the reconstruction of sections of the existing footpaths, and other ancillary works.

A copy of the order and the Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageway and footpaths on 15 July 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
