

## ROAD TRAFFIC (PUBLIC SERVICE VEHICLES) REGULATIONS (Chapter 374D)

## TABLE TO DISPLAY FARE SCALE INSIDE LANTAU TAXIS

By virtue of the powers vested in me under regulation 51(1A) of the Road Traffic (Public Service Vehicles) Regulations, Chapter 374D, I hereby give notice that, with effect from 17 July 2022, the specifications for the table showing the scale of fares chargeable for the use of Lantau taxis shall be as follows:—

- Construction* The table shall be a sticker with a plastic film and a mat surface.
- Size* The table shall measure at least 100 mm in height and 277 mm in width.
- Colour* The table shall have a yellow background with letters, Chinese characters and numbers in black.
- Lettering* The letters shall be at least 2 mm in height. The size of Chinese characters shall be at least 2 mm × 2 mm. All numbers shall be expressed in Arabic and at least 2 mm in height.
- Content* The content of the table shall follow the sample below:—

- Position* The table shall be displayed at the following locations in the vehicles:—
- the interior nearside rear door; and
  - the front dashboard on the passenger side or the front nearside door.
