

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. TD(T) 11/2021—Provision of Telecom Lines for Closed Circuits Television (CCTV) System in Tuen Mun and Yuen Long District**. The scope of service includes provision of telecommunication services for a 5-year service period for the transmission of closed circuit television (CCTV) images and control signals between on-street CCTV cameras and traffic control centres. The service is scheduled to commence in March 2023 for completion in February 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Government Logistics Department and deposited in the GLD Tender Box located at the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong, before 12.00 noon on Monday, 29 August 2022. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing date. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Monday, 29 August 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Monday, 29 August 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
