

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. DC/2023/11—Construction and Rehabilitation of Sewage Rising Mains in Southern District (Public Works Programme Item No. 4427DS)**. The works include (a) the construction of about 1.3 kilometres (km) of twin-pipe sewage rising mains with a diameter of 150 millimetres (mm) connecting Deep Water Bay Golf Club Sewage Pumping Station (SPS) to Seaview Promenade; (b) the construction of about 0.4 km of single-pipe sewage rising mains with a diameter of 100 mm connecting the Deep Water Bay No. 3 Sewage Pumping Chamber to Deep Water Bay SPS; (c) the construction of about 2.9 km of twin-pipe sewage rising mains with a diameter of 450 mm connecting Repulse Bay Main SPS to Ap Lei Chau Bridge Road; (d) the construction of a boardwalk of about 450 metres (m) in length and about 3.0 m in width along the northern bank of Staunton Creek Nullah; and ancillary works. The works are scheduled to commence in January 2024 for completion in June 2028.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 1 September 2023. Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 1 September 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 1 September 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

The tenderer has completed at least one construction contract involving roads and drainage works within the past ten years, counting from the original date set for the close of tender, in or outside Hong Kong, with an adjusted original contract sum not less than HK\$350 million. The adjusted original contract sum shall be the contract sum at the time of contract award being adjusted to current price level as stipulated in the tender documents. In the case of tender submitted by a joint venture tenderer, all participants or shareholders of the joint venture tenderer shall be collectively assessed as one entity as specified in the tender documents.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by Wednesday, 2 August 2023 to Chief Engineer/Consultants Management Division, Consultants Management Division, Sewage Services Branch, Drainage Services Department at 42/F, Revenue Tower, 5 Gloucester Road, Wan Chai, Hong Kong, meet the qualifications and conditions for participation, and the application for inclusion is duly approved on or before the tender closing date.
