

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, at grade carriageways, elevated carriageways, subway, footpaths, at grade footpaths, at grade cycle track, amenity areas, at grade amenity areas, elevated amenity areas and central reserves/refuge islands within the limit of works area as shown on Plans Nos. 60507694/C11/100 and 60507694/C11/110 to 60507694/C11/120 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 60507694/CS03/100 and 60507694/CS03/111 to 60507694/CS03/114 ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 3762 published on 25 May 2018 and 1 June 2018. The Amendment Plans and amendment scheme were referred to in G.N. 7689 published on 10 December 2021 and 17 December 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 23 July 2023 to 22 July 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, at grade carriageways, elevated carriageways, subway, footpaths, at grade footpaths, at grade cycle track, amenity areas, at grade amenity areas, elevated amenity areas and central reserves/refuge islands to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a dual two-lane Road P1 (Tung Chung East to Tai Ho section) and Tai Ho Interchange.

This notice will be affixed on or near the affected carriageways, at grade carriageways, elevated carriageways, subway, footpaths, at grade footpaths, at grade cycle track, amenity areas, at grade amenity areas, elevated amenity areas and central reserves/refuge islands on 14 July 2023.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
