In exercise of the powers vested in me by section 26 of the Buildings Ordinance, I HEREBY DECLARE that such \*building is / building works are \*dangerous / liable to become dangerous and I HEREBY ORDER you as owner to carry out the following works and such works are to be commenced by 21 August 2022 and to be completed by 20 September 2022:
- Remove loose/cracked/defective concrete, clean exposed rusty steel bars at the external wall between 1/F and 2/F facing Tung Lo Wan Road, replace/add steel bars as necessary, and reinstate with new concrete; and
- (ii) Remove all loose/defective external rendering at the external wall between 1/F and 2/F facing Tung Lo Wan Road.

All works specified in this order shall be carried out to such standard acceptable to the Building Authority and in compliance with the regulations.

3. Section 46 of the Interpretation and General Clauses Ordinance (Cap. 1) provides, inter alia, that where any Ordinance confers power upon any person to make any order, such power shall include power to substitute another order for the one already made. Pursuant to that section, the Building Authority who is empowered under section 26 of the Buildings Ordinance (Cap. 123) to make the previous order i.e. Order No. **D00016/HK/22/TB** dated **28 January 2022** is also empowered to make this order which substitutes the previous order.
