TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings within the limit of works area as shown on Plan No. SDO-Z0107 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 9482 published on 28 December 2018 and 4 January 2019. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 2 August 2023 to 1 August 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, central medians/traffic islands and pedestrian crossings to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered four-span footbridge with associated lifts, lift towers, covered staircases, covered escalators, footbridge abutments, footbridge columns and footpath at the junction of Sham Mong Road and Yen Chow Street West as well as other ancillary works.
