TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and central reserves within the limit of works area as shown on Plan No. HWDKT155A-GZ0001 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8675 published on 24 November 2017 and 1 December 2017. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 3 February 2022 to 2 February 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and central reserves to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the construction of a covered footbridge with associated covered staircase and columns connecting the elevated walkway near MTR Kowloon Bay Station Exit B and the future East Kowloon Cultural Centre, the construction of a covered ramp with associated columns connecting the aforementioned proposed covered footbridge and the existing footbridge no. KF(LNTKE), and other ancillary works.
