TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Housing (Transport) has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing at grade carriageways and at grade footpaths within the limit of works area as shown on Plans Nos. 60534575/GAZ_370/101 to 60534575/GAZ_370/103 ('the Plans') and described in the scheme annexed thereto. The Plans and scheme were referred to in G.N. 7230 published on 29 September 2017 and 6 October 2017. The Permanent Secretary for Transport and Housing (Transport) has further declared under section 17(1)(c) of the Ordinance that from 1 February 2022 to 31 January 2023, all public or private rights in, upon, under or over the sections of the existing at grade carriageways and at grade footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the widening, modification and realignment of sections of Kong Nga Po Road to a single two-lane carriageway; construction of an at grade carriageway, an elevated carriageway, at grade footpaths, an elevated footpath, verges, central medians/traffic islands, run-ins/run-outs and pedestrian crossings, as well as other ancillary works.
