PROPOSED TEMPORARY CLOSURE OF THE EXISTING TEMPORARY BUS TERMINUS AT TONKIN STREET WEST AND CONSTRUCTION OF TEMPORARY BUS LAY-BYS AT SHAM MONG ROAD

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways and footpaths, and parts of the existing planters within the limit of works area as shown on Plan No. KL85/C/GAZ-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 2918 published on 23 May 2014 and 30 May 2014. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 8 August 2022 to 7 August 2023, all public or private rights in, upon, under or over the sections of the existing carriageways and footpaths, and parts of the existing planters to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve temporary conversion of sections of the existing carriageway and footpaths at Sham Mong Road into bus lay-bys and ancillary works including civil engineering, drainage, sewerage, water and landscaping works.
