Amendments under section 7

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance'), the Permanent Secretary for Transport and Logistics proposes to amend the works and the use originally shown on Plan No. 60102100/GAZ/S5/1.6 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 8324 published under section 8(2) of the Ordinance on 2 November 2018 and 9 November 2018. The works and the use were authorized under section 11(1) of the Ordinance and the notice of authorization was published in G.N. 1015 on 1 February 2019 and 8 February 2019. The proposed amendments are shown on Amendment Plan No. 60102100/GAZ/S5/1.6A ('the Amendment Plan') and described in the amendment scheme annexed thereto. The Amendment Plan and amendment scheme have been deposited in the Land Registry.

The general nature and extent of the proposed amendments are as follows:—

- (i) revision of the originally proposed limit of works area;
- (ii) construction of a covered staircase;
- (iii) deletion of a section of the originally proposed subway, the originally proposed covered staircase and the originally proposed covered escalator at Sa Po Road;
- (iv) deletion of the originally proposed permanent closure and conversion of sections of the existing at grade carriageways into at grade footpaths, covered staircase, covered escalator and pedestrian crossings;
- (v) deletion of the originally proposed permanent closure and conversion of sections of the existing at grade footpaths into at grade carriageways, covered staircase and pedestrian crossings;
- (vi) deletion of the originally proposed permanent closure and conversion of sections of the existing amenity areas into at grade carriageway, at grade footpaths, lifts and pedestrian crossings;
- (vii) deletion of the originally proposed permanent closure and conversion of sections of the existing pedestrian crossings into at grade carriageway and at grade footpaths;
- (viii) deletion of the originally proposed temporary closure and reconstruction of sections of the existing at grade carriageway and at grade footpaths; and
- (ix) revision of the originally proposed ancillary works including drainage, water, utility and landscaping works.
