PWP ITEM NO. 6817TH— RETROFITTING OF NOISE BARRIERS ON PO NING ROAD

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageway, footpath, cycle tracks and amenity areas within the limit of works area as shown on Plan No. PNR/GZP/101 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 6265 published on 11 October 2019 and 18 October 2019. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 20 August 2022 to 19 August 2023, all public or private rights in, upon, under or over the sections of the existing carriageway, footpath, cycle tracks and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve installation of semienclosures along Po Ning Road near Tak Chak House and Tak Hong House of Hau Tak Estate; installation of cantilever noise barriers along Po Ning Road near Tak Fu House of Hau Tak Estate, Sheung Ning Road near Tak Hong House of Hau Tak Estate and Yu Wing House of Yu Ming Court; installation of vertical noise barrier along Po Ning Road near Yu Wing House and Yu Cheong House of Yu Ming Court, and Tak Yue House of Hau Tak Estate, as well as other ancillary works.

A copy of the order and the Plan may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageway, footpath, cycle tracks and amenity areas on 5 August 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
