- (i) (For Paper-based Tendering) Tenders in three (3) sets of hard copies and two (2) sets of soft copies must be sealed and clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee, Government Logistics Department, and deposited in the tender box as specified in the tender documents ('Specified Tender Box') before the tender closing date and time.
  - (ii) (For Electronic Tendering) Transmission of the Tender through the e-Tender Box shall be successfully completed in accordance with the requirements of the e-Tender Box before the tender closing date and time.
  - (iii) Late tenders or tenders not submitted in accordance with any one of the submission methods specified in (i) or (ii) above will not be accepted.
  - (iv) In case Tropical Cyclone Warning Signal No. 8 or above is hoisted, or a Black Rainstorm Warning Signal or 'extreme conditions after super typhoons' announced by the Government is/are in force, for any duration between 9.00 a.m. and 12.00 noon on the tender closing date, the tender closing time will be postponed to 12.00 noon on the first working day after the Tropical Cyclone Warning Signal No. 8 is lowered, or the Black Rainstorm Warning Signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force.
  - (v) In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
