

It is hereby notified that sealed tenders in duplicate are invited for **Contract No. SS H510—Reprovisioning of Victoria Public Mortuary (Programme No. 025NB)**.

The works include the construction of a new public mortuary to provide five cold rooms, one deep freezer, four autopsy suites, functional facilities including X-ray and Computed Tomography Scan rooms, laboratories, body identification areas, interview rooms, facilities for bereavement services, autopsy viewing rooms, gowning cum de-gowning rooms and office, etc.; and an emergency response supplies store and a personal protective equipment store at the underground cavern area, together with associated site formation and geotechnical works, piled foundation, building services installation, drainage and external works. The construction floor area is approximately 11 700 square metres. The contract is scheduled to commence in December 2023 and for completion in December 2026.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer), addressed to the Chairman, Central Tender Board, and placed in the Government Secretariat Tender Box situated in the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong before 12.00 noon on Friday, 23 September 2022. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders or tenders not deposited in the Specified Tender Box will not be accepted.

If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 23 September 2022, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 23 September 2022, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable.
