## PWP ITEM NO. B084TI PUBLIC TRANSPORT INTERCHANGE AT TAK TIN STREET AND ASSOCIATED ROAD IMPROVEMENT WORKS IN LAM TIN

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close permanently sections of the existing bus stop, carriageways, footpaths, traffic islands, pedestrian crossings, verges, lay-by, and on-street mini-bus stand; and close temporarily sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings and verges within the limit of works area as shown on Plan No. KT29/GAZ/C/DSB-01 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 257 published on 22 January 2021 and 29 January 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that as from 19 August 2022, all public or private rights in, upon, under or over the sections of the existing bus stop, carriageways, footpaths, traffic islands, pedestrian crossings, verges, lay-by and on-street mini-bus stand to be permanently closed, shall be extinguished; and from 19 August 2022 to 18 August 2023, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths, traffic islands, pedestrian crossings and verges to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve reprovision of Public Transport Interchange at Tak Tin Street, road improvement works at On Tin Street and Ping Tin Street, and other ancillary works.

This notice will be affixed on or near the affected bus stop, carriageways, footpaths, traffic islands, pedestrian crossings, verges, lay-by and on-street mini-bus stand on 19 August 2022.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means, before the expiration of one year from the date of closure, extinction, modification or restriction:—
