

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)
(Notice under section 18)

SAI SHA RESIDENTIAL AND RECREATIONAL DEVELOPMENT
SAI SHA ROAD WIDENING

TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, tracks, cycle tracks and footpaths within the limit of works area as shown on Plans Nos. 90995/02/131 and 90995/02/132 ('the Plans') and described in the scheme annexed thereto, and as amended by Amendment Plans Nos. 90995/02/131A and 90995/02/132A ('the Amendment Plans') and described in the amendment scheme annexed thereto. The Plans and scheme were referred to in G.N. 3164 published on 25 May 2001 and 1 June 2001. The Amendment Plans and amendment scheme were referred to in G.N. 2143 published on 12 April 2002 and 19 April 2002. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 27 August 2023 to 26 August 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, tracks, cycle tracks and footpaths to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve widening of Sai Sha Road between Sai O Village and Tai Tung Village from a 2-lane carriageway to a dual 2-lane carriageway; construction of a new carriageway from Tai Tung Village to Tseng Tau Village; construction of three roundabouts, one at the west of Ma Kwu Lam Village, one near Tseng Tau Village and one near Tai Tung Village; construction of three footbridges near Nai Chung Village, Kwun Hang Village and Ma Kwu Lam Village; construction of footpaths and cycle tracks; provision of access points, as well as other ancillary works.

A copy of the order, the Plans and the Amendment Plans may be inspected by members of the public free of charge at the following places and during the following hours when those offices are normally open to the public:—

This notice will be affixed on or near the affected carriageways, tracks, cycle tracks and footpaths on 18 August 2023.

Any person entitled to compensation under the Ordinance may serve upon the Secretary for Transport and Logistics a written claim, which can be submitted *via* one of the following means,

before the expiration of one year from the date of closure, extinction, modification or restriction:—

The box is available for use between 8.00 a.m. and 7.00 p.m. from Monday to Friday (except public holidays);

Personal Information Collection Statement
