- (ii) if a 'Black' Rainstorm Warning Signal is issued or 'Extreme Conditions after Super Typhoons' is announced by the Government (via the Information Services Department) within two (2) hours before the Tender closing time and/or remains in force beyond the Tender closing time; or
- (iii) when the HA announces the closure of the HA Headquarters (HAHQ) Building due to unforeseen circumstances occuring within two (2) hours before and beyond the Tender closing time; or
- (iv) if Financial Services and Treasury Bureau issues a press release to notify members of the public that the closing time for all government procurement due on that day will be extended.

However, the closing date and time of the tender will remain unchanged if Tropical Cyclone Warning Signal No. 8 or above is cancelled or lowered to No. 3 or below, or the 'Black' Rainstorm Warning Signal is cancelled or replaced by a lower level alert, or the 'Extreme Conditions after Super Typhoons' is cancelled, or the HAHQ Building is reopened, two (2) hours or more before the Tender closing time.

Late tenders or tenders not submitted in accordance with the requirements stipulated as above shall not be considered.
