

ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370)

(Notice under section 8(2))

SITE FORMATION AND INFRASTRUCTURE WORKS FOR
PUBLIC HOUSING DEVELOPMENT AT FANLING AREA 17 (ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. 426154/GZ/200 to 426154/GZ/207 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of carriageways, a cycle track, footpaths, a covered footpath, a covered footbridge, columns for covered footbridge, a covered staircase, a covered escalator, lifts, amenity areas, run-ins/run-outs, a run-in/run-out for emergency vehicle and pedestrian crossings;
- (ii) permanent closure and conversion of sections of the existing carriageways into cycle tracks, footpaths, a covered footpath, central medians/refuge islands/traffic islands and amenity areas;
- (iii) permanent closure and conversion of sections of the existing cycle tracks into carriageways, footpaths and covered footpaths;
- (iv) permanent closure and conversion of sections of the existing footpaths into carriageways, cycle tracks, a cycle parking area, covered footpaths and central medians/refuge islands/traffic islands;
- (v) permanent closure and conversion of sections of the existing central medians/refuge islands/traffic islands into carriageways;
- (vi) permanent closure and conversion of sections of the existing amenity areas into carriageways, cycle tracks, a cycle parking area, footpaths and a central median/refuge island/traffic island;
- (vii) demolition and conversion of sections of the existing planters into a carriageway and a footpath; and
- (viii) ancillary works including slope stabilisation, site formation, drainage, sewerage, water mains, utilities, lighting, landscaping, electrical and mechanical works.

The objector should describe his interest and the manner in which he alleges that he will be affected by the works or the use in his notice of objection. Objectors are requested to provide contact details to facilitate communication. A notice of objection should be delivered to the Secretary for Transport and Logistics not later than the 17th day of October 2023.

Personal Information Collection Statement

Any information, including the personal data, submitted to the Secretary for Transport and Logistics in connection with any written objections/comments will be used for the processing of the objections/comments and other related purposes. The provision of any information, including the personal data, other than the information as required under section 10(2) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) is voluntary. However, it may not be possible to process the objections/comments if such information, including the personal data, is not sufficiently provided. Any information, including the personal data, so submitted may be disclosed to the relevant government departments and other persons, organizations or agencies which are required to handle the objections/comments and related matters. Persons who have so submitted their personal data have the rights to request access to and correction of their personal data held by us.
