SHATIN TO CENTRAL LINK

**NOTICE OF ORDER AUTHORIZING
TEMPORARY CLOSURE OF A SECTION OF MA CHAI HANG ROAD,
PARTS OF MA CHAI HANG RECREATION GROUND, AND PART OF THE
FOOTBRIDGE AT MA CHAI HANG ROAD**

Notice is hereby given that under section 22(1) of the Railways Ordinance (Chapter 519), the Deputy Secretary for Transport and Logistics has, by order made on 9 August 2023 (the 'Order'), authorized:—

- (I) (a) the temporary partial closure of the section of Ma Chai Hang Road between a point about 5 metres northwest of its junction with Lung Cheung Road and a point about 10 metres south of its junction with Chuk Yuen Road, as delineated and shown in yellow on the Plan numbered SCL/G07/0015/1;
 - (b) the temporary closure of part of Ma Chai Hang Recreation Ground, as delineated and shown in green on the Plan numbered SCL/G07/0015/1; and
 - (c) the temporary closure of part of the footbridge at Ma Chai Hang Road, as delineated and shown in brown on the Plan numbered SCL/G07/0015/1,
- during the period from 13 September 2023 to 12 September 2024; and
- (II) the temporary closure of part of Ma Chai Hang Recreation Ground, as delineated and shown in blue on the Plan numbered SCL/G07/0015/1 during the period from 21 December 2023 to 12 September 2024,

for the purposes of or incidental to the railway scheme of the Shatin to Central Link. A description of the works to be carried out, the section of the road, the areas of Ma Chai Hang Recreation Ground and part of the footbridge to be affected and the manner in which they will be affected is given in the Schedule below.

A copy of this notice will be affixed on or near the road, Ma Chai Hang Recreation Ground and the footbridge affected by the Order on 25 August 2023.

Any person having a compensatable interest under the Railways Ordinance (Chapter 519) may serve a written claim upon the Secretary for Transport and Logistics so as to reach the Secretary for Transport and Logistics before the expiration of one year from the closure of the relevant part or parts of the road, Ma Chai Hang Recreation Ground and the footbridge or the extinction, modification or restriction of his private right in respect of the relevant part or parts of the road, Ma Chai Hang Recreation Ground and the footbridge affected by the Order. Claims can be submitted via one of the following means:-

- (1) by post or by hand to the Transport and Logistics Bureau's Drop-in Box No. 6 located at the 2nd Floor Entrance, East Wing, Central Government Offices, 2 Tim Mei Avenue, Tamar, Hong Kong. The box is available for use between 8:00 a.m. and 7:00 p.m. from Monday to Friday (except public holidays);

Notice is hereby given that further closure of the same part or parts of the road, Ma Chai Hang Recreation Ground and the footbridge or any of such part or parts may be required upon expiration of the Order. Details of any further order for closure will be published if and when such an order is made.
