## ROADS (WORKS, USE AND COMPENSATION) ORDINANCE (Chapter 370) (Notice under section 8(2))

## PWP ITEM NO. 7086TI IMPROVEMENT TO SO KWUN PO INTERCHANGE (ROAD WORKS)

Notice is hereby given that under powers delegated by the Secretary for Transport and Logistics under section 3(3) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370), the Permanent Secretary for Transport and Logistics proposes to execute the road works within the limit of works area as shown on Plans Nos. CE1/GZ/000 to CE1/GZ/003 ('the Plans') and described in the scheme annexed thereto, which the Plans and scheme have been deposited in the Land Registry.

The general nature of the proposed works is as follows:—

- (i) construction of an at-grade carriageway, elevated carriageways, a vehicular underpass, a footpath, a pedestrian subway, a cycle track, an amenity area/verge, pedestrian crossings, lifts and staircases;
- (ii) construction of a lift and a staircase linking San Wan Road and elevated So Kwun Po Road:
- (iii) permanent closure and conversion of sections of the existing at-grade/elevated carriageways into a footpath, central medians/refuge islands and amenity areas/verges;
- (iv) permanent closure and conversion of sections of the existing footpaths into at-grade carriageways, cycle tracks, central medians/refuge islands, amenity areas/verges and a cycle parking place;
- (v) permanent closure and conversion of sections of the existing cycle tracks into at-grade carriageways, footpaths and amenity areas/verges;
- (vi) permanent closure and conversion of sections of the existing central medians/refuge islands into at-grade carriageways and an amenity area/verge;
- (vii) permanent closure and conversion of sections of the existing amenity areas/verges into at-grade carriageways, footpaths, cycle tracks and central medians/refuge islands;
- (viii) permanent closure and conversion of sections of the existing cycle parking places into at-grade carriageways and central medians/refuge islands;
- (ix) permanent closure and conversion of sections of the existing pedestrian crossings into at-grade carriageways, footpaths and a central median/refuge island;
- (x) temporary closure and reconstruction of sections of the existing at-grade/elevated carriageways, footpaths, cycle tracks, central medians/refuge islands, amenity areas/verges and a pedestrian subway;
- (xi) demolition and conversion of sections of the existing slopes into at-grade carriageways, footpaths, cycle tracks, central medians/refuge islands, amenity areas/verges and cycle parking places;
- (xii) demolition and reconstruction of a section of the existing noise barrier;
- (xiii) demolition of a section of the existing noise barrier; and
- (xiv) ancillary works including slope stabilization, landscape, drainage, water, electrical and mechanical, street lighting and utilities works, construction of vertical noise barriers, vertical noise barriers with retaining walls, cantilever noise barriers, cantilever noise barriers with retaining walls and retaining walls, as well as installation of street furniture and traffic aids.
