TAKE NOTICE that under powers delegated by the Chief Executive, the Permanent Secretary for Transport and Logistics has ordered under section 17(1)(a) of the Roads (Works, Use and Compensation) Ordinance (Chapter 370) ('the Ordinance') to close temporarily sections of the existing carriageways, footpaths and amenity areas within the limit of works area as shown on Plan No. PLRN/GZP/208 ('the Plan') and described in the scheme annexed thereto. The Plan and scheme were referred to in G.N. 3969 published on 2 July 2021 and 9 July 2021. The Permanent Secretary for Transport and Logistics has further declared under section 17(1)(c) of the Ordinance that from 16 September 2023 to 15 September 2024, all public or private rights in, upon, under or over the sections of the existing carriageways, footpaths and amenity areas to be temporarily closed, shall be extinguished, modified or restricted, as the case may be, during that period.

The works to be carried out in association with this closure mainly involve the installation of semi-enclosure along Po Lam Road North near King Ming Court, as well as other ancillary works.

This notice will be affixed on or near the affected carriageways, footpaths and amenity areas on 25 August 2023.
