

It is hereby notified that sealed tenders in triplicate are invited for **Contract No. SD/2023/01, Cycle Track between Tsuen Wan and Tuen Mun—Stage 2A—Tuen Mun to So Kwun Wat Section (Public Works Programme Item No. 7268RS-2B1)**. The works mainly comprise:—

1. construction of a new cycle track of about 3.6 kilometres in length from Tuen Mun to So Kwun Wat with associated footpath, including a marine cycle bridge of about 200 metres in length connecting Kadoorie Beach and Cafeteria Old Beach;
2. provision of cycle parking areas;
3. associated road realignment works at Hoi Wing Road;
4. ancillary works including water, drainage, geotechnical, utilities, street lighting and landscaping works, as well as installation of traffic aids; and
5. implementation of environmental mitigation measures for the works mentioned above.

The works are scheduled to commence in the first quarter of 2024 and will take about 40 months to complete.

Tenders must be clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Central Tender Board and placed in the Government Secretariat Tender Box located at the lobby of the Public Entrance on the Ground Floor, East Wing, Central Government Office, 2 Tim Mei Avenue, Tamar, Hong Kong, before 12.00 noon on Friday, 6 October 2023. Tenders must be deposited in the tender box as specified in this tender notice ("Specified Tender Box") before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on Friday, 6 October 2023, the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on Friday, 6 October 2023, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. Selective tendering is adopted. Contractors on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category or joint ventures with participation of local and/or overseas contractors with the lead participant or the major shareholder being a contractor on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category who also meet the following qualifications and other conditions for participation stipulated in the tender documents are invited to tender:—

- (i) The tenderer, or the participants/shareholders collectively in case of a joint venture tenderer, has completed at least 1 contract involving roads and drainage works plus 1 contract involving bridgeworks OR 1 contract involving both roads and drainage works and bridgeworks within the past 10 years, counting from the original date set for the close of tender, in or outside Hong Kong, with an adjusted contract sum of not less than HK\$ 200 million. The adjusted contract sum shall be the awarded contract sum being adjusted to current price level as stipulated in the tender document.

Contractors not yet on the List of Approved Contractors for Public Works in Group C under the Roads and Drainage Category may also submit a tender if they submit a request for participation together with a duly completed application for inclusion in the above-mentioned approved list/category by 22 September 2023 to Chief Engineer/S4, South Development Office, Civil Engineering and Development Department, 6/F South Tower, West Kowloon Government
