

It is hereby notified that tenders are invited for the **Collection of Traffic Flow Information for Annual Traffic Census 2023 and 2024 (Tender Ref.: TD(T) 5/2022)**. The service mainly includes:—

- (i) to collect traffic flow information for Annual Traffic Census 2023 and 2024, by means including installation and operation of the automatic vehicle counting systems provided by the Government, and maintenance of the automatic vehicle counting systems in 2023 and 2024; and
- (ii) to collect traffic information by manual counting and preparation of the Annual Traffic Census reports for 2023 and 2024.

The service is expected to commence in around mid-December 2022 and will take about 33 months to complete.

For paper-based Tendering, tenders must be sealed and clearly marked with the tender reference and the subject of the tender on the outside of the envelope (but should not bear any indication which may relate the tender to the tenderer) addressed to the Chairman, Tender Opening Committee of the Government Logistics Department, and placed in the Government Logistics Department Tender Box situated on the Ground Floor, North Point Government Offices, 333 Java Road, North Point, Hong Kong before 12.00 noon (Hong Kong time) on 7 October 2022 (Friday). Tenders must be deposited in the tender box as specified in this tender notice ('Specified Tender Box') before the tender closing time. Late tenders and tenders not deposited in the Specified Tender Box will not be accepted. If tropical cyclone warning signal No. 8 or above is hoisted, or a black rainstorm warning signal or 'extreme conditions after super typhoons' announced by the Government is/are in force at any time between 9.00 a.m. and 12.00 noon on 7 October 2022 (Friday), the tender closing time will be postponed to 12.00 noon on the first working day after the tropical cyclone warning signal No. 8 is lowered, or the black rainstorm warning signal or the 'extreme conditions after super typhoons' announced by the Government has/have ceased to be in force. In case of blockage of the public access to the location of the Specified Tender Box at any time between 9.00 a.m. and 12.00 noon on the tender closing date, the Government will announce extension of the tender closing time until further notice. Following removal of the blockage, the Government will announce the extended tender closing time as soon as practicable. The above announcements will be made *via* press releases on the website on Information Services Department (<http://www.info.gov.hk/gia/general/today.htm>).

Open tendering is adopted. All interested service providers have experience in traffic surveys and meet the requirements and other conditions for participation stipulated in the tender documents are invited to tender. All time references are Hong Kong time.

This tender is covered by the Agreement on Government Procurement of the World Trade Organization and will not involve electronic auction. This notice also serves as a summary notice required under the Agreement on Government Procurement of the World Trade Organization.

The Government of the Hong Kong Special Administrative Region does not bind itself to accept the lowest tender or any tender irrespective of whether the tender is the lowest bid or where the assessment of the tenders is based on a marking scheme or formula approach, the tender has the highest overall score.

The Government of the Hong Kong Special Administrative Region reserves the right to negotiate with any tenderer about the terms of the offer.
